Planning and Compulsory Purchase Act 2004

The Town and Country Planning (Local Planning) (England) Regulations 2012 (Reg 19).

The council invites you to submit representations on the Sevenoaks District Local Plan (Regulation 19). This statement sets out the following information:

Subject matter and geographical area covered

The Sevenoaks District Local Plan (Regulation 19) has been published and covers the entire Sevenoaks district administrative area. The Plan sets out the strategic spatial planning policy framework for the district and includes:

- The spatial vision, strategic objectives, and spatial development strategy
- Site allocations and policies
- A suite of strategic and development management policies to be used to determine planning applications within the district
- Implementation and delivery policies
- A monitoring and implementation framework
- A Policies Map

Period for making representations

Representations of support or objection are invited on the plan from 23 July 2026. To ensure your views are considered, all representations must be received by the Council no later than 11.59pm on Thursday 17 September 2026.

Please note that representations received after the deadline will be marked as late and may not be considered by the Planning Inspector.
